## **Purpose and Values**

The Association of Global Event Suppliers (AGES) is a not-for-profit organisation based in Switzerland, which was founded in June 2014 to act as a label for quality, safety and reliability in temporary infrastructure provision for major events.

All member companies and executives of AGES are committed to our "Mission Statement" and ethical corporate citizenship in accordance to our "Code of Ethics and Professional Conduct".

Furthermore, AGES promotes sustainability and undertakes considerable efforts through business activities and initiatives to support and encourage all members to improve their sustainability performance. # **Implementation**

AGES encourages its members to develop their own specific Sustainability Strategy and Policies to align with this Sustainability Statement and to take account of emerging issues and industry best practices.



For that purpose, AGES has produced and distributed a comprehensive "Sustainability Guide" for Event Suppliers to improve their environmental, social and economic performance. The document shall be available free of charge to all members as well as to non-members wishing to improve their sustainability performance. The Sustainability Guide marks the commitment of AGES which shall organize experts' presentations, webinars, case studies or other activities to enforce the implementation.

As mentioned in the Sustainability Guide, we recommend to our members a management systems approach in accordance with internationally recognized standards ISO 14001 and/or ISO 20121.

In addition to complying with all applicable legal requirements, all members of AGES agree to incorporate sustainability objectives in their strategies, and commit to continual improvement of their sustainability performance. This will be evaluated through regular management reviews and reporting on progress.

AGES will support its members in developing and adopting their Sustainability Strategy and Policies, and encourages the sharing of best practices and learnings to advance the sustainability performance of our industry.

This Sustainability Statement has been adopted by the members of AGES at the General Assembly Meeting in St. Augustine, Florida, in 2016 and has been reviewed by the Board of AGES in 2022.
