Corporate Documents

Start of membership and duration

The Applicant will be informed about the acceptance or not of his application within 1 months after receipt of the completed Application Form by AGES. The Applicant acknowledges that the membership will start only after the receipt of the full membership fee by AGES. The membership is automatically renewed from year to year, unless terminated by a party.

Termination of membership

The membership can be terminated by:

- Member by written notice in accordance to clause 8 of the Articles of Incorporation
- AGES by written notice in accordance to clause 9 of the Articles of Incorporation or, at our sole discretion, upon breach of the declaration upon honor.

Payments

Payments for membership fee are to be made in EUR within 30 days of date of invoice, net, through bank transfer. VAT (7.7%) is applicable to Swiss companies only.
